## **Board of Supervisors meeting**

David Owens, Chairman of the Board of Supervisors opened the Board of Supervisors meeting at 8:19 pm. In attendance were Supervisors Glenn Frederick and Aileen Parrish, Secretary Carolyn Matalon, Treasurer Nette Stejskal, Zoning Officer Dave Gargula, Township Engineer Pat Walsh, Planning Commission members Les and Stephanie Town, Park and Recreation Board member Bill Maslanka and a few residents.

#### **New Business**

<u>Executive Session</u>- David Owens announced an Executive session was held on 3/24/16 to discuss potential litigation.

Resolution #16-12- David Owens read Resolution #16-12 which designates Treasurer Nette Stejskal as a signer on all forms and documents for relief and emergency assistance for the January 2016 snow event. Glenn Frederick made a motion to adopt Resolution #16-12 as read. Aileen Parrish seconded and the motion carried unanimously.

### **Old Business**

Good Hope Road project- Dave Gargula discussed Unit price analysis, 2016 Road work project costs and yardage requirements for Good Hope Rd, Chambers Rock Rd and Arc Corner. Joe Ferguson provided the Board of Supervisors a list of Township roads that he had concerns about. The Board discussed this list and will address the work needed when the remaining road budget allows. David Owens made a motion to advertise the 2016 road work. Glenn Frederick seconded and the motion carried unanimously.

Proposed Event Ordinance draft- Glenn Frederick read the differences that his Ordinance draft contained vs. the previous Ordinance that was discussed in a hearing. Barbara Schroeder noted that there is a FEMA manual on Special Events and it gives the purpose as a protection of the health, safety and welfare of people. The term Special Event should be defined. The Planning Commission will review this draft as well as research the FEMA manual on Special Events. The Board of Supevisors will discuss the draft again on 4/25/16.

McKinnon/Hamerick- Mr. McKinnon and Mr Hamerick discussed the shared driveway with Zoning Officer Dave Gargula. Mr. Hamerick asked the Board if he and Mr McKinnon could meet with Township attorney Tom Oeste to discuss the changes to the Zoning Ordinance Book. The Board of Supervisors did not allow this request until the Township discussed this with Township attorney. Township Secretary Carolyn Matalon will discuss the request with Township attorney Tom Oeste.
