Board of Supervisors Meeting

Glenn Frederick, Chairman of the Board of Supervisors opened the meeting at 7:06 pm. In attendance were Supervisors Chris Whetham and Aileen Parrish, Secretary Carolyn Matalon, Planning Commission member Brian Sachs, Park and Recreation member Bill Maslanka and several residents.

Glenn Frederick announced an Executive Session was held tonight to discuss Personnel.

New Business

7/10/18 Comprehensive Plan update/Landscapes 3 meeting minutes. Glenn Frederick made a motion to accept the minutes of 7/10/18 as read. Aileen Parrish seconded and the motion carried unanimously.

Proposed Ordinance/All Way Stop @ Flint Hill Rd and Good Hope Rd- The Board discussed the All Way Stop warrant analysis obtained from McMahon Associates Inc. The study as outlined in the August 23, 2018 letter from McMahon Associates proves that an all-way stop control is warranted at the intersection of Good Hope Rd and Flint Hill Rd. An Ordinance must be passed prior to the proper installation of the appropriate signage. Glenn Frederick made a motion to approve the advertisement of an Ordinance for the All Way Stop at the intersection of Good Hope Rd and Flint Hill Rd. Chris Whetham seconded and the motion carried unanimously. The information about a new All Way Stop will be shared on Facebook and the Township website.

Stormwater MS4 Summit- Glenn Frederick made a motion to approve Township Engineer Ron Ragan attending the Chester County MS4 Summit on 9/14 and splitting the cost with the 3 other municipalities he represents. Aileen Parrish seconded and the motion carried unanimously.

Until a new employee is trained to monitor the Windsor Treatment plant the Board agreed to have Windsor Treatment Operator Fred Walton monitor the Treatment plant 2 additional days a week.
